2. By opening a trading account under this MT4 VPS Service Program, the client acknowledges that she/he has read, and agreed to Royal's terms and conditions as well as the service provider's terms and conditions
3. For a client to be eligible to obtain a free VPS service, s/he should trade a volume of 20 lots or more per calendar month
4. For a Money Manager to be eligible to obtain a free VPS service, s/he should trade a volume of 30 lots or more per calendar month
5. If a client does not reach the required volume stated above in clause 3 and 4, Royal reserves the right to remove the VPS service or in case the client wishes to continue benefiting from the VPS service then the client should cover the fee of the VPS cost from their own money
